

Seekapa Terms & Conditions – Ramadan Promo

INTRODUCTION

Seekapa is a trading platform operated by Bluepine Ltd, a Seychelles investment firm, authorized and regulated by the Financial Services Authority of Seychelles with license number SD183. (hereinafter "We", "Our", "Us", or the "Company").

Subject to the “Eligibility” section below, Seekapa Terms & Conditions – Ramadan Promo (the “Terms, Promotion”) apply to any party (hereinafter “the Client”, “You” or “Trader”) that registers with the Company and meets the criteria as described below.

These Terms will be effective from 01/03/2025 until the last day of Ramadan (the “Effective Period, Promotion Period”).

We may, in our sole discretion, amend or terminate these Terms at any time without prior notice or by giving no less than 5 Business Days' notice. Such notice may be provided to you by email or other means, but in any case, it shall be deemed provided upon updating the Company’s website.

By entering Transactions in any instruments offered by the Company, you specifically agree to be bound by these Terms.

ELIGIBILITY

You shall be eligible to enter the Ramadan Draw under these Terms only if you meet the criteria set forth below:

- Deposit a minimum of \$470 in your trading account between the first day of Ramadan and the last day of Ramadan.
- This Promotion is open exclusively to residents of the GCC countries (Bahrain, Kuwait, Oman, Qatar, Saudi Arabia, and United Arab Emirates).
- You shall be eligible to win Prizes offered through the Competition only if the below criteria are satisfied:
 - The verification/KYC procedures must be completed.
 - Deposits that are already made before the Competition starts will not be counted.
